All support staff posts are subject to the Asylum and Immigration requirements.

Purpose of Post

- Under the direction/guidance of senior staff (Office Manager), provide general administrative/financial support to the school.

Principal Duties and Responsibilities

1. Organisation

- Undertake reception duties, answering general telephone and face to face enquiries and signing in visitors.
- Assist with pupil welfare duties, looking after sick pupils, liaising with parents/staff etc.
- Assist in arrangements for schools' trips, events etc.
- Liaison with EWO and parents.

2. Administration

- Provide general clerical/administrative support e.g. photocopying, filing, faxing, completing standard forms, responding to routine correspondence.
- Update and maintain computer records.
- Produce lists and analysis of data from manual and computer records.
- Produce lists/information/data as required e.g. pupils' data.
- Undertake word-processing and other IT based tasks.
- Take notes at meetings.
- Sort and distribute mail.
- Undertake administrative procedures, registers, school meals etc.
- Maintain and collate pupil reports.
- Undertake routine administration of school lettings and other uses of school premises.
- Maintain stock and supplies and re-order as required.

3. Resources

- Operate relevant equipment/ICT packages (e.g. Word, Excel, databases, spreadsheets, Internet).
- Respond to routine correspondence.

- Maintain stock and supplies, cataloguing and distributing as required.
- Operate uniform/snack/other 'shops' within the school.
- Provide general advice and guidance to staff, pupils and others.
- Undertake general financial administration e.g. processing orders, collecting and recording cash, assisting with banking.

4. Other Responsibilities

- Be aware of and comply with all school policies and procedures.
- Be aware of and support difference and ensure equal opportunities for all.
- Contribute to the overall ethos/work/aims of the school.
- Appreciate and support the role of other professionals.
- Attend and participate in relevant meetings as required.
- Participate in training and other learning activities and performance development as required.

5. Safeguarding
